- **3. How to Enter:** During the Sweepstakes Period, there are two (2) ways you can earn entry into the Sweepstakes:
  - a) You will be automatically entered into the Sweepstakes when you complete an online money transfer from the United States (outbound only) to a recipient's eligible Visa Debit card who resides in one (1) of the available thirty-three (33) receive countries, as follows:
    - Albania, Argentina, Bangladesh, Costa Rica, Czech Republic, Dominican Republic, Ecuador, El Salvador, Georgia, Greece, Guatemala, Haiti, Honduras, India, Italy, Jamaica, Kenya, Lithuania, Malaysia, Mexico, New Zealand, Nicaragua, Panama, Peru, Philippines, Romania, Singapore, Spain, Sri Lanka, Thailand, Turkey, United Kingdom and Vietnam
  - b) To enter without making a money transfer (an "Alternate Method of Entry" or "AMOE"), visit moneygram.com/visadebitsweepstakes and complete the online submission form by providing (i) your full legal name, (ii) mobile number, (iii) email address, and (iv) date of birth. All AMOEs will be entered into the random drawing.

Sponsor will contact the potential winners via email provided on his or her MoneyGram profile or Sweepstakes submission.
