If you opted in to receive additional communications from Sponsor, you may receive emails regarding Sponsor's offers, products, and services.
- **9. General Conditions:** Sponsor reserves the right to cancel, replace, suspend and/or modify the Sweepstakes, or any part of it, for any reason including if any fraud, technical failures or any other factor beyond Sponsor's reasonable

control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion.
