

MoneyGram 2022 Sweepstakes Official Rules

- c) To enter without making a money transfer (an "Alternate Method of Entry" or "AMOE"), visit moneygram.com/2022sweepstakes and complete the online submission form by providing (i) your full legal name, (ii) mobile number, (iii) email address, and (iv) date of birth. All AMOEs will be entered into the random drawing.

One entry per person permitted. Duplicate entries will be rejected for entry in the Sweepstakes. All entries must be earned/received and recorded by Sponsor during the Sweepstakes Period in order to qualify for the drawing. A money transfer must be completed and received by recipient to be entered into the drawing. A cancelled or incomplete money transfer will not be counted as an entry. Sponsor will award twenty (20) prizes. The odds of winning depend on the number of eligible entries received.

Sponsor will select twenty (20) potential winners and five (5) back-up potential winners by random drawing on Monday, May 23, 2022 by 5:00 P.M. (CT) following the Sweepstakes Period.

Sponsor will contact the potential winners via email provided on his or her MoneyGram profile or Sweepstakes submission.

If a winner is chosen from Canada, before being declared a winner, the potential winner must first correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question posed by email or telephone.

The potential winner from the United States or Canada will be required to sign and return to Sponsor, within ten (10) days an affidavit of eligibility and publicity release ("Release") in order to claim a prize. If the potential winner cannot be contacted within twenty-four (24) hours or fails to sign and return the Release within the required time period, the potential winner forfeits the prize.
